WHEREAS, the Human Resources Department completed a base wage compensation study of the Psychiatric Social Worker classification series which includes the Psychiatric Social Worker I/II and Senior Psychiatric Social Worker classifications; and

WHEREAS, the base wage salary of the benchmark classification of Psychiatric Social Worker II was found to be approximately 6.59% below the salary mean of the County's comparable agencies' classifications and it is recommended to adjust the base wage salary of the Psychiatric Social Worker II classification by the respective approximate percentage at top step and maintain the current spread of the classification series; and

WHEREAS, to implement the recommendations, the action requires the Personnel Policies and Practices Resolution No. 98-394 Appendix A to be amended; NOW, THEREFORE,
