WHEREAS, the Arts Council for Monterey County has been the official arts planning agency for the region and the designated local partner for the California Arts Council since it was founded in 1982;

WHEREAS, the mission of the Arts Council for Monterey County is to improve the quality of life for everyone in the region through the arts; and

WHEREAS, funding from the California Arts Council will substantially aid in the efforts of the Arts Council for Monterey County to strengthen the local economy and enrich the quality of life by expanding access to high quality and high impact arts programs.
