WHEREAS, the **Women’s Health Center** expanded their health services to the community with a higher level of care specifically for women; and

WHEREAS, the **Women’s Health Center** is a separate building that is roughly 3,000 square feet in size and includes additional exam rooms, full-time OB-GYN and ultrasound services, a state-of-the-art mammogram machine and classrooms for perinatal and nutritional education; and

WHEREAS, the **Women’s Health Center** will expand access to treatment, regular preventative care, and provide residents with the resources they need to maintain and improve their health; and

WHEREAS, the **Women’s Health Center** will provide additional exam rooms for patient care and classrooms for patient education to improve medical literacy to our underserved population; and

WHEREAS, currently the Soledad Medical Clinic performs 44,000 visits each year and with the completion of **Women’s Health Center**, they will have the capacity to provide an additional 20,000 visits per year; and

WHEREAS, the **Women’s Health Center** is the only health facility in South Monterey County to provide full time specialty care locally and will help address the medical needs of the community.
