WHEREAS, Natividad Medical Center (NMC) administration staff recently conducted a classification study to determine if there is sufficient market data to help support the creation of a certified Central Sterile Technician classification; and

WHEREAS, the study found that there was sufficient market data available to support the creation of a certified series to include the Certified Sterile Processing Technician and Senior Certified Sterile Processing Technician classifications; and

WHEREAS, to establish a salary for the new classification series, NMC completed an external base wage compensation analysis and found there were three (3) matches within the County’s six (6) hospital comparable agencies and it is recommended to establish the salary of the Senior Certified Sterile Processing Technician classification using the existing spread between the non-certified journey- and lead-level classifications which is currently 15%; and

WHEREAS, NMC recommends the reallocation of the Central Sterile Technician positions to Certified Sterile Processing Technician and the Senior Central Sterile Technician position to Senior Certified Sterile Processing Technician; NOW, THEREFORE,

BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey as follows:
