- a. Accepting the 2022 Annual Report of the mileage of the maintained County roads; and)

WHEREAS, the California Streets and Highway Code, Section 2121, requires counties to submit to the California Department of Transportation in May of each year, any additions or exclusions from its mileage of maintained County roads, specifying the termini and mileage of each route added and excluded; and

WHEREAS, the California Department of Transportation certified to the State Controller in the year 2021 that the total mileage of Monterey County maintained roads was 1,264.35 miles; and

WHEREAS, the Board now finds for 2022 the total mileage of Monterey County maintained roads is 1,262.95 miles in accordance with the additions, exclusions or corrections to the tabulation as indicated in EXHIBIT 1 - SUMMARY SHEET 2022 MILEAGE OF MAINTAINED COUNTY ROADS MONTEREY COUNTY for the year 2022, attached hereto and incorporated by this reference as a part of this resolution; and

NOW THEREFORE, BE IT RESOLVED THAT, the Board of Supervisors of Monterey County hereby:

- 1. Approves the 2022 Annual Report of the mileage of the maintained County roads; and
- 2. Authorizes the Director of Public Works, Facilities and Parks to submit this Resolution with Exhibit 1 and any corresponding maps and tabulations to the California Department of Transportation.
