WHEREAS, it is the mission of the Elections Department to conduct elections in a secure manner;

WHEREAS, the department recommends completing construction of walls to secure voting system equipment and ballots;

WHEREAS, the Capital Improvements Program scored Project 8404 to complete aforementioned construction at 76 points out of 100, including the maximum number of points possible in three categories: critical to security, community impact and infrastructure, and 13 points out of 15 for regulatory compliance;

WHEREAS, the Resource Management Agency has engaged a vendor to complete construction at a Project Cost Estimate of \$470,639 and the Elections Department has sufficient appropriations to fund Project 8404 in Fiscal Year 2018-2019 with a transfer of \$208,291 and the original estimate of \$262,348 that from Fund 402 Unassigned Fund Balance that had previously been transferred;

NOW, THEREFORE, BE IT RESOLVED by the Monterey County Board of Supervisors as follows:

- a. Approve a budget increase for Elections construction Project No. 8404 in FY 2018-19 Fund 402-Capital Projects list from \$262,348 to \$470,639;
- b. Authorize and direct the Auditor-Controller to transfer \$208,291 for Project No. 8404 in FY 2018-19 from Elections, General Fund 001-1410-8064-ELE001 to Capital Projects Fund 402-3000-8468-RMA014, where sufficient appropriations are available in Elections adopted budget to cover the transfer (4/5th vote required); and
- c.
