

WHEREAS, the Board of Supervisors received a report on the Financial Condition of the Lakes Enterprise Fund;

WHEREAS, the Board of Supervisors received a presentation on Tier options for operating Lake San Antonio;

WHEREAS, prior to finalizing the Reservoir Recreation Plan for Lake San Antonio, the RMA sought specific direction from the Board on how Lake San Antonio should be operated moving forward;

WHEREAS, the Board of Supervisors provided direction to proceed with Tier I for the interim management of Parks operations for the Lakes through November 2019, which requires an increase in appropriations of \$813,634 to effect this direction; and

WHEREAS, the Board of Supervisors will provide long-term direction on how Lake San Antonio should be operated after receiving the Final Reservoir Recreation Plan for Lake San Antonio, which will provide a comprehensive analysis of the Lake operations, including attendance comparisons to other County Parks facilities, anticipated to be brought to the Board for consideration in late September 2019;

WHEREAS, RMA-Parks requires one additional position: (1) Administrative Operations Manager to meet operational needs in the County Parks system;


