Resolution No.: 26-110

- Adopt a Resolution :
- a. Amending the Health Department Fiscal Year (FY) 2025-26 Adopted Budget to increase appropriations by \$150,000 in the Emergency Medical Services Agency (016-4000-8111- HEA009) to reimburse physicians as required by Health and Safety Code Chapter 2.5 Section 1797.98a., financed with available fund balance (4/5th vote required); and
 - b. Amending the Health Department FY 2025-26 Adopted Budget to increase appropriations and estimated revenue by \$250,000 in the Emergency Medical Services Agency to meet operational needs (001-4000-8109- HEA006) (4/5th vote required); and
 - c. Authorizing and directing the Auditor-Controller and County Administrative Office to incorporate the changes in the FY 2025-26 Health Department Adopted Budget 016-4000-8111- HEA009 and 001-4000-8109- HEA006.

WHEREAS, the Health Department requested to amend the Fiscal Year 2025-26 Adopted Budget (016-4000-8111-HEA009) to increase appropriations in the Emergency Medical Services Agency by \$150,000 to reimburse physicians as required by Health and Safety Code Chapter 2.5 Section 1797.98a., financed with available fund balance: and

WHEREAS, Health Department requested to amend the Fiscal Year 2025-26 Adopted Budget (001-4000-8109- HEA006) to increase appropriations and estimated revenue in the Emergency Medical Services Agency by \$250,000 to meet operational needs; and

WHEREAS, the increased revenue and appropriations requested will accommodate the Health Department's Fiscal Year 2025-26 financial activity.

NOW, THEREFORE, the County of Monterey Board of Supervisors hereby resolved to approve the following:

- a) Appropriations are increased in the Health Department Fiscal Year (FY) 2025-26 Adopted Budget by \$150,000 in the Emergency Medical Services Bureau (016-4000-8111- HEA009) to reimburse physicians as required by Health and Safety Code Chapter 2.5 Section 1797.98a., financed with available fund balance (4/5 vote required); and
- b) Appropriations and estimated revenue are increased in the Health Department FY 2025-26 Adopted Budget by \$250,000 in the Emergency Medical Services Bureau (001-4000-8109- HEA006) (4/5 vote required); and
- d. The Auditor-Controller is authorized and directed to incorporate the approved budget modifications, and County Administrative Office to reflect the changes in the FY 2025-26 Health Department Adopted Budget 016-4000-8111- HEA009 and 001-4000-8109- HEA006.


