SUMMARY:

The proposed project includes construction of a 5,700 square foot single family dwelling with an attached 804 square foot garage, 256 square foot covered front porch, 224 square foot patio, a 400 square foot detached Accessory Dwelling Unit, and associated site improvements including the removal of three Coast live oak trees.

On February 18, 2025 the project was scheduled to be heard by the Greater Monterey Peninsula Land Use Advisory Committee (LUAC), however due to a lack of quorum, the project was continued to the next LUAC meeting date of March 3, 2025. Pursuant to Section 8f of the Board of Supervisors adopted LUAC Procedures, a matter may not be continued more than two times due to a lack of quorum unless requested by the applicant. Therefore, staff is recommending the Zoning Administrator continue this hearing to March 13, 2025 to ensure the project has the opportunity to be heard by the LUAC once more.
