WHEREAS, Deputy Wesley Wong was sworn in by Sheriff David B. "Bud" Cook in 1988 after his graduation from the Basic Police Academy; serving under six Monterey County Sheriffs: David B. "Bud" Cook, Norm Hicks, Gordon Sonne, Mike Kanalakis, Scott Miller and Steve Bernal; and

WHEREAS, Deputy Wesley Wong performed exceptionally well as a Deputy Sheriff assigned to: Corrections, Transportation, Classification, and to the Correctional Emergency Team for eleven years, of which he was the squad leader for nine years; and

WHEREAS, Deputy Wesley Wong received a lifesaving award in December 1999; and

WHEREAS, Deputy Wesley Wong was awarded the Monterey County Sheriff's Medal of Honor in March 2004; he received several letters of appreciation from local agencies, and was also nominated Employee the Month and Employee of the Year for outstanding performance; and

WHEREAS, Deputy Wesley Wong was a member of Northern California Gang Investigators, Central Coast Gang Task Force, and a member of the Association of Tactical Officers; and

WHEREAS, Deputy Wesley Wong, because of his hard work and dedication to the Monterey County Sheriff's Office, received, met, or exceeded standards on numerous performance evaluations; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Monterey on behalf of all residents thereof, acknowledges, commends and thanks **Deputy Wesley Wong** for his thirty-two years of exemplary public service to the residents of Monterey County, as a valued member of the Monterey County Sheriff's Office.
