**WHEREAS,** in 2008 **Kasey Tertulien** began training people from her home, then taught classes at Bailey's gym on Broadway; and

**WHEREAS,** after 2010, **Kasey Tertulien** opened **Kasey's Fitness Academy** on San Antonio Drive and taught a full schedule of classes, managed a gym, and trained clients before relocating her business to several locations on Broadway; and

**WHEREAS,** while **Kasey Tertulien** has offered fitness, strength training, and martial arts at Kasey's Fitness Academy, her overarching goal is the building of confidence, discipline, health, and focus of her clients.

**NOW THEREFORE, BE IT RESOLVED,** that the Monterey County Board of Supervisors, on behalf of the County and all its residents thereof, recognize **Kasey Tertulien** and **Kasey's Fitness Academy** for their contributions to the community and to Monterey County, and hereby congratulates them upon being selected as the recipient of the **King City Chamber of Commerce and Agriculture's 2022 Business of the Year Award.**
