WHEREAS, the Public Defender experienced increased costs in Prison Defense and due to unanticipated costs of employee termination payoffs and settlements;

WHEREAS, the Public Defender anticipates additional reimbursements from the State for Prison Defense of \$196,922 in the current fiscal year, offset by an estimated shortfall in client registration fees of approximately \$17,600, yielding a net additional revenue of \$179,322.

WHEREAS, the approval of the requested revenue and appropriations increases will help defray increased costs in Prison Defense and unanticipated costs of employee termination payoffs and settlements.

NOW, THEREFORE, BE IT RESOLVED THAT, the Board of Supervisors does hereby authorize the Auditor-Controller's Office to adjust the Public Defender's FY 2016-17 Adopted Budget to increase revenues in the amount of \$179,322 in PUB001-001-2270-8168-5050, and increase appropriations in the amount of \$179,322 in PUB001-001-2270-8168-6383.
