WHEREAS, on July 8, 1986 the County of Monterey Board of Supervisors established the Big Sur Multi-Agency Advisory Council by Resolution No. 86-443;

WHEREAS, on April 26, 1994, the Board of Supervisors amended Resolution No. 86-443 to include the 27th District State Senate Member, and the Council has benefited from these additions;

WHEREAS, on March 18, 1997, the Board of Supervisors amended Resolution No. 86-443 to include the 15th Senate District, and the Council has benefitted from these additions;

WHEREAS, on May 16, 2000, On April 26, 1994, the Board of Supervisors amended Resolution No. 86-443 to include the Monterey Bay National Marine Sanctuary; and

WHEREAS, the Council had functioned well to facilitate communication and coordination amongst the governmental agencies with jurisdiction in the Big Sur Area and the Big Sur Residents, property owners, and businesses.


