

**AMENDMENT NO. 6  
TO AGREEMENT No. A-11065 / MYA348  
BETWEEN Kronos Inc. AND

This Amendment No.6 to Agreement No. A-11065/MYA348 ("Agreement"), dated November 20, 2007 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and Kronos Incorporated (Contractor), with respect to the following:

**RECITALS**

**WHEREAS**, the County and Contractor amended the Agreement previously on April 1, 2010 via Amendment No. 1, on October 1, 2010 via Amendment No. 2, and on October 1, 2011 via Amendment No. 3; and on December 5, 2012 via Renewal and Amendment No. 4, and on January 1, 2014 via Amendment No. 5; and

**WHEREAS**, the County and Contractor wish to amend the Agreement to extend the term end date to allow for existing services to continue.

**AGREEMENT**

**NOW, THEREFORE**, the parties agree to amend the Agreement as follows:


1. Section 2. "TERM OF AGREEMENT" shall be amended by removing, "*The term of this Agreement is from November 7, 2007 to June 30, 2014 unless sooner terminated pursuant to this Agreement*" and replacing it with "*The term of this Agreement is from November 7, 2007 to June 30, 2015 unless sooner terminated pursuant to this Agreement*".
2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement and Renewal and Amendment No. 4, and Amendment Nos. 1, 2, 3, 5 are unchanged and unaffected by this Amendment No. 6 and shall continue in full force and effect as set forth in the Agreement.
3. A copy of this Amendment No. 6 and all previous amendments shall be attached to the original Agreement No. (A-11065/MYA348).
4. The effective date of this Amendment No. 6 is July 1, 2014.


