AMENDMENT #2 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN THE COUNTY OF MONTEREY

& JEFFREY GOBELL

THIS AMENDMENT is made to the AGREEMENT for legal representation services by and between Jeffrey Gobell, hereinafter "Attorney", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and Attorney have executed Amendment No. 1 to the Agreement to extend the term of the agreement through June 30, 2019, and to increase the total amount of the AGREEMENT by \$82,125.00 to compensate Attorney for the period of July 1, 2018 through June 30, 2019; and

WHEREAS, the County and Attorney wish to amend the Agreement to change the insurance provisions of the Agreement.

NOW THEREFORE, the County and Attorney hereby agree to amend the AGREEMENT in the following manner:

- 1. Exhibit C, attached to this amendment No. 2, shall be added to the Agreement, deleting the requirement that Attorney provide an endorsement naming the County as an additional insured on his general commercial liability and automobile insurance policies.
- 2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by the AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 3. A copy of this AMENDMENT #2 shall be attached to the original AGREEMENT executed by the County on July 25, 2017.

Attorney's general commercial and automobile insurance carrier is USAA Auto Insurance Company, which will not provide him with an endorsement to his general commercial and automobile insurance policies, naming the County as an additional insured. The parties agree that Attorney will not be required to provide County with an endorsement to his general commercial and automobile insurance policies, naming it as an additional insured, notwithstanding Paragraph 7.02 of the Agreement. Attorney agrees to provide a Certificate of Insurance, indicating general commercial and automobile coverage in the required amounts as specified in Paragraph 7.02, and to maintain such coverage continuously throughout the term of the Agreement, as specified in Paragraph 7.02.
