## AMENDMENT NO. 5 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN COUNTY OF MONTEREY AND BENDER ROSENTHAL, INC.

THIS AMENDMENT NO. 5 to the Professional Services Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and Bender Rosenthal, Inc. (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into a Professional Services Agreement with County on February 1, 2012 (hereinafter, "Agreement") to provide on-call real estate services through January 31, 2014 for an amount not to exceed \$100,000; and

WHEREAS, Agreement was amended by the Parties on April 29, 2013 (hereinafter, "Amendment No. 1", including Exhibit B-I – Federal Provisions) to revise Exhibit B – Federal Provisions with no increase to the Agreement's not to exceed amount and with no extension to the Agreement's term; and

WHEREAS, Agreement was amended by the Parties on October 31, 2013 (hereinafter, "Amendment No. 2") to extend the term for one (1) additional year through January 31, 2015 with no increase to the Agreement's not to exceed amount; and

WHEREAS, Agreement was amended by the Parties on December 8, 2014 (hereinafter, "Amendment No. 3") to extend the term for one (1) additional year through January 31, 2016 and to increase the Agreement amount by \$100,000 which resulted in a total not to exceed amount of \$200,000; and

WHEREAS, Agreement was amended by the Parties on October 20, 2015 (hereinafter, "Amendment No. 4", including Exhibit B-2 – Federal Provisions) to revise Exhibit B-1 – Federal Provisions and to extend the term for one (1) additional year through January 31, 2017 with no increase to the Agreement's not to exceed amount; and

WHEREAS, the County has a continued need for on-call real estate services, beyond the anticipated five (5) year Agreement term allowed per Request for Qualifications (RFQ) #10249; and

WHEREAS, additional time is necessary to allow County staff to prepare and process a new RFQ; and

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

1. Amend the first sentence of Paragraph 3, "Term of Agreement", to read as follows:

The term of this Agreement is from <u>January 31, 2012</u> to <u>January 31, 2018</u>, unless sooner terminated pursuant to the terms of this Agreement.

2. Invoices under this Agreement shall be submitted monthly and promptly, and in accordance with Paragraph 6, "Payment Conditions", of the Agreement. All invoices shall reference the Multi-Year Agreement (MYA) number #3000\*270, Project name and associated Purchase Order number, and an original hardcopy shall be sent to the following:
