WHEREAS, Section 2.68.080 of the County Code prescribes the purpose and process for adopting and maintaining an Emergency Operations Plan (EOP) for the County of Monterey including its Annexes; and

WHEREAS, an EOP is a key component of an emergency operations program, establishing the overall authority, roles and functions performed during response to major emergencies/disasters. It also sets forth those overall authorities, roles and functions for disaster preparedness, recovery and mitigation phases of emergency management when carried out in conjunction with responding to a disaster. Incident or hazard specific Annexes, that are part of the EOP, are created to provide specific direction for various types of emergency response incidents and functions, and

WHEREAS, the adoption of the EOP Annex – Evacuation and Transportation Plan, is a significant milestone in the County of Monterey's extensive efforts to create a more reliable and consistent method of determining areas of the County needing evacuation due to emergencies, notifying the residents involved, and transporting them to safe areas, and

WHEREAS, in accordance with Section 2.68.040 and 2.68.080 of the County Code the Evacuation and Transportation Plan included a working group consisting of stakeholders with review and comment from the Monterey County Disaster Council who is responsible to make recommendation for approval of the plan and annex to the Board of Supervisors. The revision process was carried out in accordance with FEMA's Comprehensive Planning Guide 101 Version 2.0.

NOW, THEREFORE, BE IT RESOLVED, that based on the recommendation from the Monterey County Disaster Council, the Board of Supervisors does hereby approve the 2021 Evacuation and Transportation Plan.
