

WHEREAS, the Special Districts Annual Report (Report) was presented to the Board of Supervisors on December 11, 2018, providing an overview of all Special Districts, including thirty-seven active County Service Areas;

WHEREAS, the Report focused on the financial and operational status of these districts and strategies to ensure future sustainability of each district;

WHEREAS, residents of County Service Area 17-Rancho Tierra Grande (CSA 17) have expressed concern about existing infrastructure needs and have requested repairs and upgrades, including substantial drainage work and road repairs, road striping, and right-of-way tree maintenance;

WHEREAS, residents of County Service Area 25-Carmel Valley Golf and Country Club (CSA 25) have expressed concern about existing infrastructure needs and have requested repairs and upgrades, including substantial drainage work, road repair, road striping, and right-of-way tree maintenance;

WHEREAS, residents of County Service Area 75-Chualar (CSA 75) have expressed concern about existing infrastructure needs and have requested repairs and upgrades, specifically for the addition of new sidewalks and increased streetlighting;

WHEREAS, CSA 75 is in negotiations to transfer ownership of its sanitation system and requires a Sewer System Assessment to facilitate negotiations related to the transfer of ownership and which should be completed regardless of the disposition of said system;

WHEREAS, an Engineer's Report is necessary for each of these CSAs to support a Proposition 218 election to establish assessments sufficient to fund infrastructure improvements;

WHEREAS, for CSA 17, it is necessary to increase the FY 2019-20 Adopted Budget appropriations in Fund 057, Appropriation Unit RMA053, by \$34,522, financed by Fund 057, Unassigned Fund Balance, Account 3101, to fund the Engineer's Report;

WHEREAS, for CSA 25, it is necessary to increase the FY 2019-20 Adopted Budget appropriations in Fund 062, Appropriation Unit RMA058, by \$30,905, financed by Fund 062, Unassigned Fund Balance, Account 3101, to fund the Engineer's Report;

WHEREAS, for CSA 75, it is necessary to increase the FY 2019-20 Adopted Budget appropriations in Fund 093, Appropriation Unit RMA088, by \$46,040, financed by Fund 093, Unassigned Fund Balance, Account 3101, to fund the Engineer's Report and Sewer System Assessment; and

WHEREAS, these recommendations promote the County of Monterey Board of Supervisors Strategic Initiatives related to Administration, Health & Human Services, Infrastructure, and Public Safety. Engineer's Reports and subsequent Proposition 218 elections will establish assessments that allow for effective administration of the CSAs, fund repairs and maintenance of storm drains, road and sidewalk infrastructure, which provide enhanced public safety benefits to property owners and the public. The Sewer Assessment will provide information about the overall condition of the system to facilitate transfer negotiations.

NOW, THEREFORE, BE IT RESOLVED THAT the Monterey County Board of Supervisors hereby resolves to approve the following:


