KNOW ALL MEN BY THESE PRESENTS:

That Donald D. Chapin Jr. and Barbara A. Chapin, also known as Barbara A. Chapin; Donald D. Chapin Jr. and Barbara A. Chapin, Co-Trustees of the Chapin Living Trust dated April 27, 1999; and Donald D. Chapin, Jr., Successor Trustee, Non-Exempt Marital Trust Under The Chapin Living Trust Dated November 10, 1989., as Principal, hereinafter called Contractor, and TRAVELERS CASUALTY AND SURETY COMPANY OF AMERICA, as Surety, hereinafter called Surety, are held and firmly bound unto County of Monterey, Department of Public Works, 168 W. Alisal Street, 2nd Floor, Salinas, CA 93901, as Obligee, hereinafter called Owner, in the penal sum of **Eighteen Thousand, One Hundred Fifty-Two 50/100 (\$18,152.50)**, for the payment whereof Contractor and Surety bind themselves, their heirs, executors, administrators, successors, and assigns, jointly and severally, firmly by these presents.

WHEREAS, Contractor has by written agreement entered into a contract with Owner for **Subdivision Improvement Agreement for Axtell Street Properties Improvement, Parcels C - H**, copy of which contract is by reference made a part hereof.


WHEREAS, said contract provides that the Principal will furnish a bond in the amount of Twenty Percent of Estimated Total Cost conditioned to guarantee for the period of one year after approval of said job, by the owner, against defects in workmanship and materials which may become apparent during said period

NOW, THEREFORE, the condition of this obligation is such that, if Contractor shall remedy any defects due to faulty materials or workmanship which shall appear within a period of **ONE** year from the date of substantial completion of the work provided for in the Contract, then this obligation to be void; otherwise to remain in full force and effect.

PROVIDED, HOWEVER, that Owner shall give Contractor and Surety notice of observed defects with reasonable promptness.

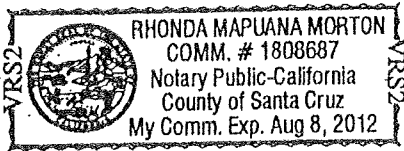
