Background

- Need for local trauma center "Golden Hour"
- RFQ issued by County late 2012 authorizing EMS to identify a hospital and medical staff to develop a Level II Trauma Center
- RFQ scored by an independent team using Title
 22 and American College of Surgeons' criteria







Background

- Independent review panel recommendation for NMC to prepare for Level II Trauma accepted by Board of Supervisors on Oct 1, 2013
- Six requirements needed to be met
- Response to conditions and financial plan was presented to the Board of Supervisors on January 28, 2014.

Response

Neurosurgery

- Contracts have been signed with five Neurosurgeons all with Level I and II Trauma experience
- Contract completed with local Neurosurgery group.
- As of October 1, 2014 NMC has 24/7 Neurosurgery coverage.
- A clinical nurse specialist was onsite in August to provide extensive training to the Critical Care and medical/surgical staff on the care of the neurosurgical patient.

 - Trauma support services 12.0 FTEs
- To date NMC has filled the following positions: 44.4 FTEs.
