(previously AMEC Environmental and Infrastructure, Inc.) to continue to provide consulting engineering services for feasibility analysis, preliminary engineering, environmental review, and final engineering services for the San Lucas Water District Public Water Supply Replacement Project under Request for Qualifications (RFQ) No. 10433, to renew and extend the expiration date from September 30, 2016 for approximately seventeen (17) additional months through February 19, 2018, for a revised term from February 19, 2014 to February 19, 2018, with the option to extend the Agreement for one (1) additional one (1) year period, with no associated dollar amount increase to the total not to exceed amount of \$440,000; and
- b. Authorized the Contracts/Purchasing Officer or Contracts/Purchasing Supervisor to execute Renewal and Amendment No. 1 to the Professional Services Agreement and future amendments to the Agreement where the amendments do not significantly alter the scope of work or change the approved amount of the Agreement.

**RENEWAL AND AMENDMENT NO. 1  
TO PROFESSIONAL SERVICES AGREEMENT  
BETWEEN COUNTY OF MONTEREY AND  
AMEC FOSTER WHEELER ENVIRONMENT & INFRASTRUCTURE, INC.**

**THIS RENEWAL AND AMENDMENT NO. 1** to Professional Services Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and Amec Foster Wheeler Environment & Infrastructure, Inc. (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

**WHEREAS**, CONTRACTOR's predecessor in interest, AMEC Environmental & Infrastructure, Inc., previously entered into a Professional Services Agreement with County on February 19, 2014 (hereinafter, "Agreement"), for the provision of providing a variety of tasks related to the analysis of alternatives, selection of a preferred option, preparation of pre-environmental design, environmental review, final engineering, right-of-way acquisition, and permitting to provide a new permanent long-term public water supply (hereinafter, "services") for the San Lucas Water District (hereinafter, "Project") under Request for Qualifications (RFQ) #10433 through September 30, 2016 for an amount not to exceed \$440,000; and

**WHEREAS**, effective January 1, 2015, CONTRACTOR changed its legal entity name and is presently conducting business in the name of "Amec Foster Wheeler Environment & Infrastructure, Inc." (CONTRACTOR), which reflects the combination of CONTRACTOR's parent company, AMEC plc, and Foster Wheeler AG; and

**WHEREAS**, the Agreement expired pursuant to its terms on September 30, 2016; and

**WHEREAS**, the Parties wish to renew the Agreement retroactive to September 30, 2016; and

**WHEREAS**, the County has a continued need for services; and

**WHEREAS**, Task 1, Review/Update Water Quality Deficiencies in District's Existing Water Supply, and Task 2, Feasibility Study/Report, of Exhibit A – Scope of Services/Payment Provisions of the renewed Agreement have been completed; and

**WHEREAS**, at the formal direction of the State Water Resources Control Board (SWRCB), work on Task 3, Preliminary Engineering/Project Description, was suspended prior to completion; and

**WHEREAS**, additional time is necessary to allow the County to determine the modifications to the CONTRACTOR's original scope of services necessary to comply with said direction of the SWRCB, and to allow CONTRACTOR additional time to complete the Project's services as may be modified in accordance with such direction; and

**WHEREAS**, the Parties wish to extend the term of the renewed Agreement for approximately seventeen (17) months through and including February 19, 2018 with no associated dollar amount increase to allow CONTRACTOR to continue to provide services identified in this Agreement and as amended by this RENEWAL AND AMENDMENT NO. 1.

NOW THEREFORE,

For valuable consideration, the sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. The Agreement is renewed retroactive to September 30, 2016, and all of its provisions shall be deemed to have been in effect continuously since that time.

2. Amend the first sentence of Section 3, "Term of Agreement", to read as follows:

The term of the AGREEMENT shall commence on February 19, 2014 through and including February 19, 2018, with the option to extend the AGREEMENT for one (1) additional one (1) year period.

3. In all places within the renewed Agreement, any reference to AMEC Environmental and Infrastructure, Inc. is hereby replaced with Amec Foster Wheeler Environment & Infrastructure, Inc.

4. Invoices under this Agreement shall be submitted monthly and promptly, and in accordance with Section 6, "Payment Conditions", of the Agreement. All invoices shall reference the Multi-Year Agreement (MYA) number (MYA #3000\*1451), Project name and associated Purchase Order number, and an original hardcopy shall be sent to the following:
