## RENEWAL AGREEMENT & AMENDMENT #1 TO MASTER AGREEMENT FOR PERSONNEL CONSULTING SERVICES By and between COUNTY OF MONTEREY

&

## RENNE SLOAN HOLTZMAN SAKAI, LLP.

This RENEWAL AGREEMENT & AMENDMENT #1 is made to the MASTER AGREEMENT for the provision of PERSONNEL CONSULTING SERVICES by and between RENNE SLOAN HOLTZMAN SAKAI, LLP., hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the MASTER AGREEMENT expired pursuant to its terms on June 30, 2013; and

WHEREAS, the County and CONTRACTOR agree to renew the MASTER AGREEMENT retroactive to July 1, 2013 and to extend the term of the Agreement for an additional six (6) months through and including December 31, 2013; and

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT as follows:

- The AGREEMENT is renewed retroactive to July 01, 2013, and all of its provisions shall be deemed to have been in effect continuously since that time.
- Section 3.1, "The term shall commence July 1, 2008 through and including June 30, 2013.", is replaced with "This Agreement shall be in full force and effect, commencing from June 27, 2008 through December 31, 2013.".
- Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT and previously executed AMENDMENT I are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- A copy of the AMENDMENT shall be attached to the original AGREEMENT dated June 27, 2008.
