**WHEREAS, Andy D'Arrigo** will retire from his position as Chairman Emeritus of D'Arrigo Bros. Co., of CA on December 31, 2015 after more than 64 years of dedicated service; and

WHEREAS, Andy D'Arrigo has demonstrated a high degree of professionalism, integrity, dedication, and devotion while serving at the forefront of the company created by his father and uncle since 1951. He is the namesake of the Andy Boy label carried by the company for decades; and

WHEREAS, Andy D'Arrigo was born in Stockton, CA and grew up in San Jose, CA. He graduated from UC Davis with a Bachelor's Degree in Science with a Major in Plant Science; and

WHEREAS, Andy D'Arrigo has seen many advances in agriculture and the technology associated with it. D'Arrigo Bros. Co. brought broccoli, sweet anise (fennel) and broccoli rabe to the Salinas Valley. The company is credited with the first broccoli transcontinental shipment by rail in the US in the 1920s; and

WHEREAS, Andy D'Arrigo has served on numerous boards, committees and commissions to include: President, Western Growers Association; Honoring Growing Future Farmers; Boy Scouts of America; Monterey Bay Association Council; and

WHEREAS, Andy D'Arrigo has received numerous awards and honors including: Western Growers Association Award of Honor; Ag Leadership Award; Valley of the World Hall of Fame for "Outstanding Achievement as a Pioneer of the Salinas Valley Ag Industry" award; E.E. Gene Harden Lifetime Achievement Award; and
