Adopt Resolution Commending **Sergeant Daniel B. Robison** Upon His Retirement After Twenty-Eight Years of Public Service with the Monterey County Sheriff's Office.

WHEREAS, Sergeant Daniel B. Robison enlisted in the United States Army in 1987 and served with the 7th Infantry Division 9th Infantry Regiment as well as the 123rd Aviation Regiment receiving numerous commendation medals and achievement awards for his service and was honorably discharged from the United States Army in March of 1992; and

WHEREAS, In 1994, Sergeant Daniel B. Robison enrolled in the 92nd police academy at Gavilan Community College as a non-affiliate, and a few months after graduating from the academy, started the hiring process with the Monterey County Sheriff's Office and was sworn in by Sheriff Norm Hicks on February 21, 1995; and

WHEREAS, In 1995 Sergeant Daniel B. Robison began working in the Corrections Division and after completing probation was promoted to Corporal/FTO where during his time in Corrections, he received two lifesaving awards; one for a stricken fellow deputy and one for a civilian who had collapsed outside the jail; and

WHEREAS, In 1996 Sergeant Daniel B. Robison transferred to the patrol division and started field training at the coastal station where he trained under Deputies Neil Shaw, Greg Clark, Shaheen Jorgensen, and Mark Stevens and was nominated twice for Deputy of the Year; and

WHEREAS, Sergeant Daniel B. Robison made numerous cases including robberies and burglaries resulting in recognition for professional excellence and was appointed to the Monterey County Search and Rescue Team where he spent three years serving as a team member, trainer, and team leader; and

WHEREAS, Sergeant Daniel B. Robison was appointed by Sheriff Gordon Sonne as the At-Risk Youth Coordinator tasked with developing after-school programs revolving around sports and education as well as assisting in juvenile impact programs including the boxing program, "Neutral Corner"; and

WHEREAS, When Sheriff Mike Kanalakis took office **Sergeant Daniel B. Robison** returned to patrol where he served on both the Monterey Station and then transferred to the Central Station where he was soon promoted to FTO training dozens of deputies and in August of 2006 he received the Sheriff's Meritorious Service Award for assistance with the Interagency Counter Narco-Terrorism Task Force which he had worked with the previous year; and

WHEREAS, Sergeant Daniel B. Robison was promoted to Detective and assigned to the coroner's office where he investigated and documented death cases throughout Monterey County for the next 4 years; and

WHEREAS, In 2016 Sergeant Daniel B. Robison was promoted to Sergeant where he was assigned to the Corrections and Enforcement Operation Bureaus; and

WHEREAS, In 2018 **Sergeant Daniel B. Robison** received the Distinguished Service Award for saving the life of a three-year-old drowning victim and that same year was again nominated for Deputy of the Year for working with the Monterey County Office of Emergency Services to start a Naloxone distribution to all sworn staff both in the jail as well as on the street which immediately saw positive results with several lives saved using the Naloxone distributed; and

WHEREAS, The Monterey County Sheriff's Office extends its deepest gratitude to **Sergeant Daniel B. Robison** for his steadfast dedication, sacrifice, and exemplary service as his unwavering commitment to the safety and well-being of our community has left an enduring legacy.

NOW, THEREFORE BE IT RESOLVED, that the County of Monterey Board of Supervisors, on behalf of the County and all residents thereof, hereby acknowledges, commends, and thanks **Sergeant Daniel B. Robison** for his twenty-eight years of exemplary public service to the residents of Monterey County, as a valued member of the Monterey County Sheriff's Office.

BE IT FURTHER RESOLVED, that the County of Monterey Board of Supervisors wishes him success, health, and happiness in all his future endeavors and much joy in his well-deserved retirement.
