AMENDMENT NO. 2 TO AGREEMENT COUNTY OF MONTEREY AND N. REX AWALT CORPORATION DBA AQUA ENGINEERING

THIS Amendment No. 2 (Amendment No. 2) is made to the Standard Agreement (Agreement) between N. Rex Awalt Corporation dba Aqua Engineering, ("CONTRACTOR"), and the County of Monterey, a political subdivision of the State of California, ("County") (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, the Parties entered into a Standard Agreement on January 18, 2022, and Amendment No. 1 on August 28, 2024 to allow CONTRACTOR to provide on-call maintenance and repair services for water and sanitation sew systems, booster pump systems, backflow preventers, water quality testing and other utility system related services; and

WHEREAS, the County and CONTRACTOR wish to amend the Agreement to extend the term; and

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the Agreement in the following manner:

- 1. Section 3.0 "TERM OF AGREEMENT" shall be deleted in its entirety and replaced with the following:
 - The term of this Agreement is from January 5, 2022 to January 4, 2026, unless sooner terminated pursuant to the terms of this Agreement. This Agreement is of no force or effect until signed by both CONTRCTOR and County and with County signing last, and CONTRACTOR may not commence work before County signs this Agreement.
- 2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment and shall continue in full force and effect as set forth in the Agreement.
- 3. A copy of this Amendment No. 2 shall be attached to the Agreement and incorporated as if fully set forth in the Agreement.
