WHEREAS, Meg Clovis has served as the Cultural Affairs Manager for the Monterey County Parks Department since 1981, she oversaw site development, public programming, exhibitions and collections management at the county's agricultural history museum, *Monterey County Agricultural and Rural Life Museum*, and the county's environmental education center; and

WHEREAS, Meg Clovis was married to Robert Clovis and has two children, Elizabeth Welden-Smith, Michael Welden, and one grandchild, Finnian Welden-Smith; and

WHEREAS, Meg Clovis received her Bachelor of Arts in Art History from Mills College followed by an Master of Arts in Preservation Studies from Boston University, with an emphasis on American Architectural History; and

WHEREAS, Meg Clovis wrote Monterey County's Historic Preservation Ordinance, Mills Act Ordinance and prepared the certified local government application, she staffed Monterey County's Historic Resources Review Board, she is responsible for the Certified Local Government program administration including grants and the annual report, she oversaw preparation of Spreckels Historic District Design Review Guidelines, Monterey County's Historic Preservation Plan, Cultural Resource Survey, and the context statements for agricultural properties in the Salinas Valley, North County Planning Area, South County Planning Area, Pebble Beach, she also wrote Monterey County's Historic Preservation Ordinance; and

WHEREAS, Meg Clovis managed the restoration and furnishing of three historic house museums owned by Monterey County Parks including, the Porter-Vallejo House in Pajaro, and the Japanese School in Castroville, California, and oversaw maintenance of Monterey County Parks owned historic structures; and

WHEREAS Meg Clovis is active in Monterey County's museum and historic preservation communities, serving as staff to the County's Historic Resources Review Board and Historical Advisory Commission; and

WHEREAS, Meg Clovis is a member of the Historic Resources Board for the City of Salinas and is an annual presenter for the County's AgKnowledge Executive Leadership Program; and

WHEREAS, Meg Clovis has written two books on Monterey County history, *The Salinas Valley* and *Monterey County's North Coast*; and

WHEREAS, Meg Clovis volunteers with various community organizations which include her role as President of the Monterey County Historical Society, member of Salinas Historical Resources Board, and member of grants committee for the Community Foundation for Monterey County; and

WHEREAS, Meg Clovis has represented Monterey County and Monterey County Parks Department with the highest level of professionalism and integrity.
