**WHEREAS, Deputy Blaine Councilman** has been named the Monterey County Sheriff's Office Corrections Operations Bureau Deputy of the Year for 2015, he was nominated by Commanders Garrett Sanders and Archie Warren; and

**WHEREAS, Deputy Blaine Councilman** was born in City of King, California, raised in the cities of King, Greenfield, and Lockwood, and educated in the City of King, California, he has spent two and a half years of his law enforcement career with the Monterey County Sheriff's Office; and

**WHEREAS, Deputy Blaine Councilman** was hired as a Deputy Sheriff Recruit on March 11, 2013, was promoted to Deputy Sheriff on August 16, 2013, served one year in the Patrol Division completing his field training on March 11, 2014, was transferred to the County Jail on September of 2014, where he completed his jail training and also worked the patrol division as needed; and

**WHEREAS, Deputy Blaine Councilman's** responsibilities as correctional deputy included maintaining the safety and security of the facility, the welfare of all inmates, its employees and the general public, which included responding to and investigating suspicious activities and making arrests, writing reports and assisting the general public; and

**WHEREAS, Deputy Blaine Councilman** was very proactive and organized numerous searches inside the facility confiscating large amounts of contraband, made several self-initiated felony arrests, leading to the seizure of dangerous controlled substances that could have made it into the facility and the seizure of a loaded firearm by a visitor; and

**WHEREAS, Deputy Blaine Councilman** while performing his duties, noticed an inmate outside the top tier railing of a housing pod stating he was going to attempt suicide, he entered the pod and was able to stop the inmate from jumping and provided him the proper help; and

**WHEREAS, Deputy Blaine Councilman** on his own initiative, sought and utilized additional training classes, beyond the minimums mandated by the Commission on Peace Officers Standards and Training, and the Board of State and Community Corrections and continues to seek out educational opportunities; and

**WHEREAS, Deputy Blaine Councilman's** daily positive attitude, outstanding work ethic and professional demeanor have proven to be a great example for all who wear the badge; and

**WHEREAS,** as a result of his outstanding work ethic and positive demeanor, **Deputy Blaine Councilman** was awarded Corrections Operations Bureau Deputy of the Year for 2015, and **Deputy Blaine Councilman** will be presented with the Sheriff's Office Deputy of the Year badge; and

**NOW, THEREFORE BE IT RESOLVED** that the Monterey County Board of Supervisors recognizes **Deputy Blaine Councilman** as the Monterey County Sheriff's Office COB Deputy of the Year for 2015 and **Deputy Blaine Councilman** is recognized for his OUTSTANDING public service on behalf of all the people of Monterey County and for all of his many achievements and accomplishments.
