WHEREAS, County receives health realignment funds from the State of California to provide various services in the areas of communicable disease, chronic disease prevention, immunizations, maternal and adolescent health, public nursing, and direct health services to indigents in the County; and

WHEREAS, County believes that partnering with a local primary care provider of medical services is an effective strategy to promote and facilitate access to medical care to low-income Monterey County residents with access-to-care challenges; and
