WHEREAS, the Service Employees International Union, Local 2015 (SEIU) is the recognized bargaining unit for the In-Home Support Services providers ("Providers") in the County of Monterey (the "County"); and

WHEREAS, the County's In-Home Supportive Services Public Authority (the "Public Authority") and SEIU are required under the Meyers-Milias-Brown Act to meet and confer in good faith regarding wages, hours and other terms and conditions of employment; and

WHEREAS, the Public Authority and SEIU having met and conferred in good faith, reached a total tentative agreement on a successor collective bargaining agreement for the Providers; and

WHEREAS, the Department of Social Services General Fund Contribution base will require budgetary increases in FY 2026-27 by \$3,412,704 and FY 2027-28 by \$616,328.

NOW, THEREFORE, BE IT RESOLVED, the Board of Supervisors of the County of Monterey hereby enacts the following:

- 1. Pursuant to the Tentative Agreement, effective upon Union ratification, Board and State approval, the Public Authority SOC449 Rate package results in the following items: State Minimum Hourly Wage increased to \$16.90 (Monterey County's IHSS Base wage is \$15.00), increased the wage supplemental to \$3.74, decreased the administrative rate to \$0.17, and increased the payroll tax rate \$2.41. The health benefit increased \$0.14 from \$0.66 to \$0.80 per hour, for an overall total Public Authority Rate of \$24.02 as indicated in the SOC449 rate changed attached.
- 2. Effective November 1, 2025, the Public Authority will increase the health and safety supply fund by an additional \$5,000 per fiscal year, for a total of \$15,000 annually for protective supplies for the IHSS Providers.
- 3. Effective January 1, 2026, the Public Authority will increase the wage supplement by \$1.00 from a \$2.74 to \$3.74 that floats above the base wage for a total of \$20.64 per hour.
- 4. Effective July 1, 2026, the Public Authority will increase the wage supplement by \$0.40 from \$3.74 to \$4.14 that floats above the base wage for a total of \$21.04 per hour.

- 5. Effective July 1, 2027, the Public Authority will increase the wage supplement by \$0.35 from \$4.14 to \$4.49 that floats above the base wage for a total of \$21.39 per hour.
- 6. Effective during the negotiations for a successor agreement with the Public Authority, a stipend will be provided for each negotiations meeting, up to six (6) providers, equivalent to five hours at their current effective rate of pay.
- 7. Increases Department's General Fund Contribution base budget for FY 2026-27 in the amount of \$3,412,704.
- 8. Increases Department's General Fund Contribution base budget for FY 2027-28 in the amount of \$616,328.
