LEGAL DESCRIPTION

Situate in Section 26, Township 24 South, Range 10 East, Mount Diablo Meridian, in the County of Monterey, State of California, and being a portion of that certain parcel of land conveyed by deed from Richard Clark Johnston to Richard C. Johnston, et ux, dated April 30, 2004, and recorded May 7, 2004 as Document No. 2004045547, Official Records of Monterey County, said portion being more particularly described as follows:

- 3) N. 00°18'40" E., 65.00 feet (North, deed) to the point of beginning.

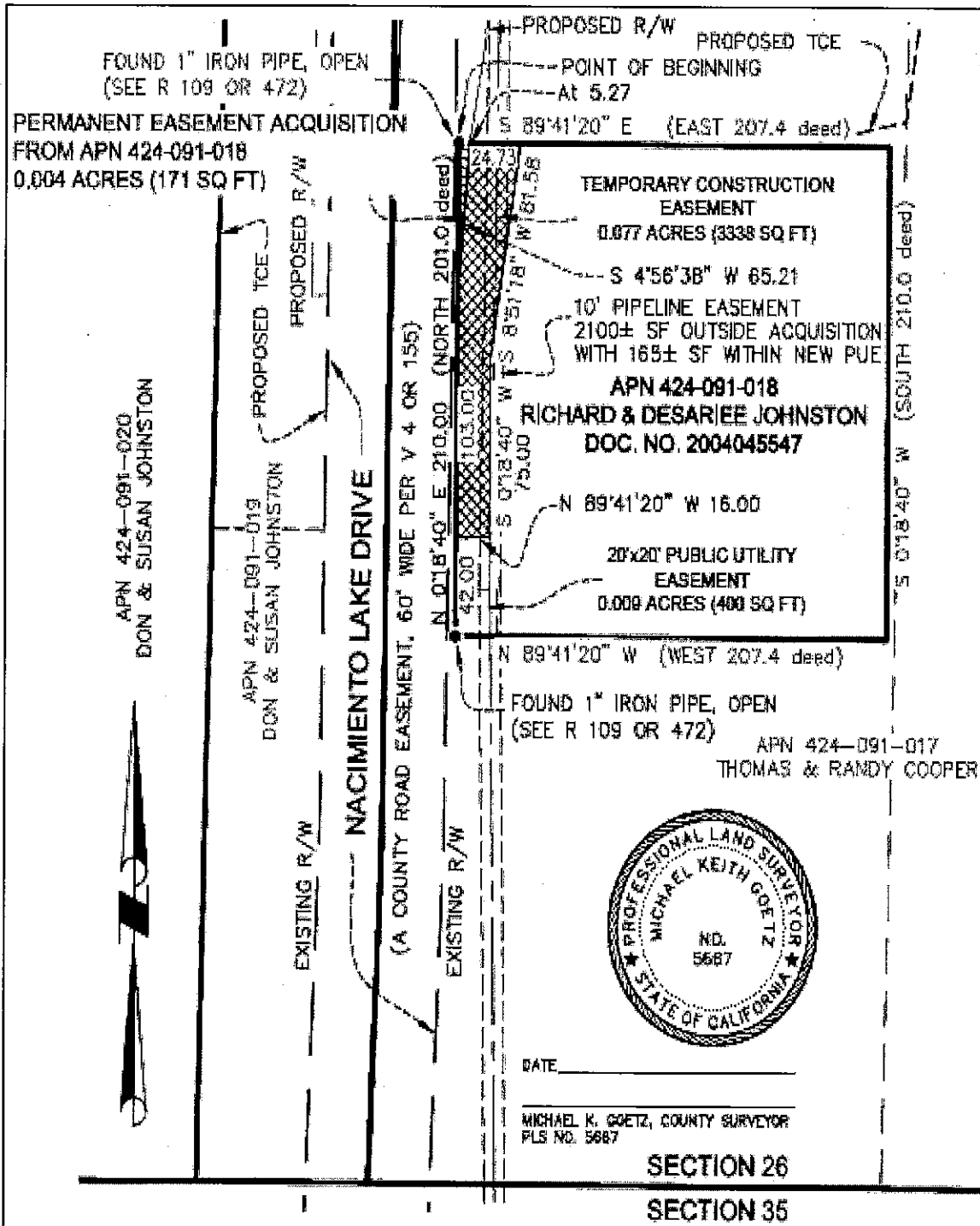

Johnston, husband and wife as joint tenants (GRANTORS)**, hereby **GRANT** to the **County of Monterey, a political subdivision of the State of California**, property for the Nacimiento Lake Drive Bridge Project in the County of Monterey, State of California, for public roadway and utility purposes as described and depicted in Exhibit "C" attached hereto and incorporated herein by this reference.

This Temporary Construction Easement shall be for the purpose of construction activities related to the Project including, but not limited to use for ingress and egress, road and sidewalk construction areas, parking of vehicles and all other activities whatsoever in nature incidental to the construction of the specified project.

This Temporary Construction Easement shall become effective upon deposit of the full amount of purchase price into escrow by **GRANTEE** and shall terminate either upon the completion of construction of that portion of the project lying adjacent to the above described parcel, or 24-months from the effective date, whichever date occurs first. **GRANTEE** reserves the right to extend the period of this Temporary Construction Easement by an additional 12-months at the monthly rate specified in the appraisal of the property.

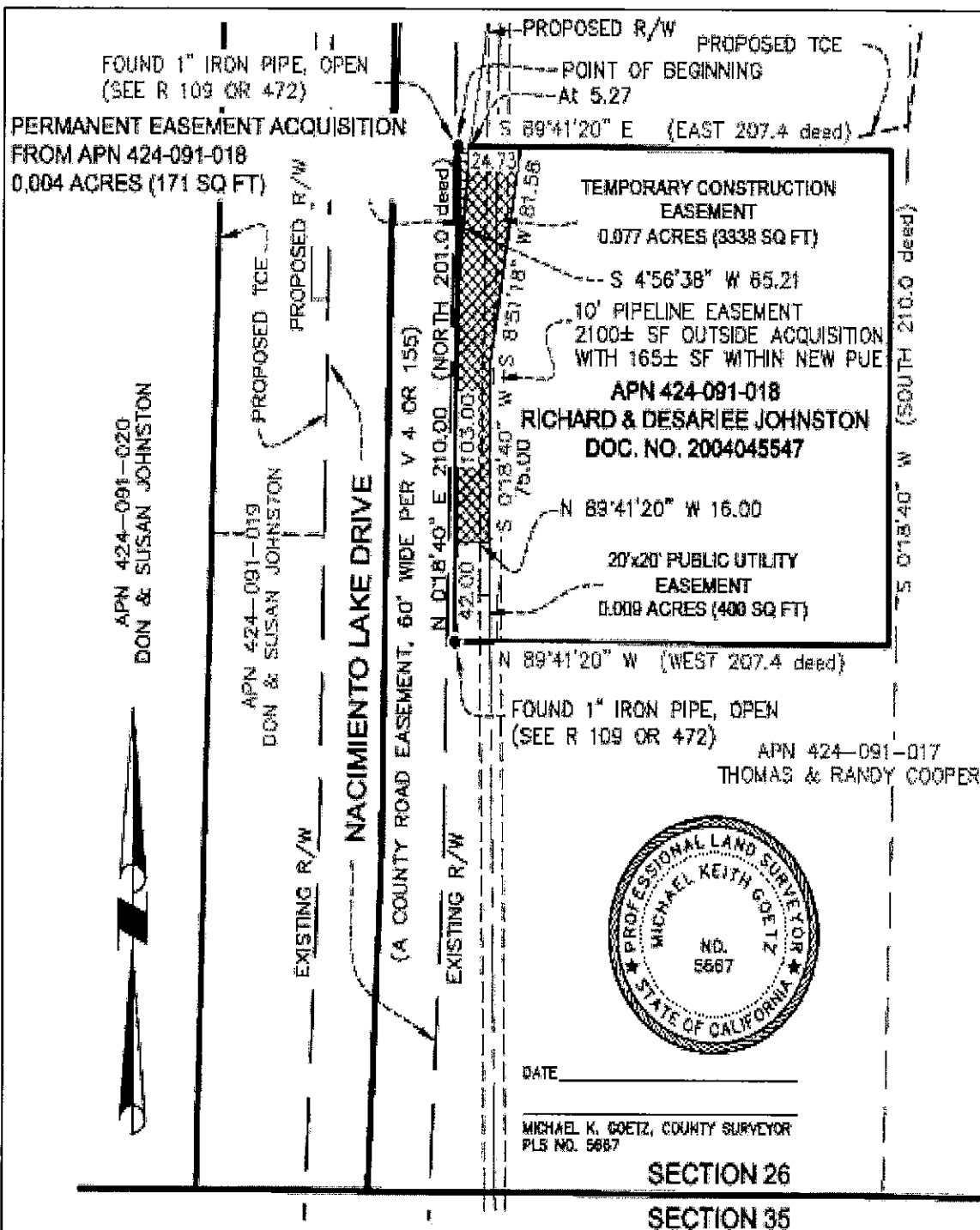
