Resolution Honoring **Dr. Duane Hyde** as a Monterey County Military and Veterans Services Advisory Commission 2013 "Veteran of the Year"

WHEREAS, each year the County of Monterey and the Monterey County Veterans Services Advisory Commission honors those who have made a significant contribution to their communities, are strong motivators, have demonstrated extraordinary professional competence and are role models for veterans and the community as a whole; and

WHEREAS, *Dr. Duane Hyde*, joined the Army as a private and left as a staff sergeant, serving as a *foot soldier* from 1942 until 1946 as well as valiantly defending and fighting for our country when he served during World War Two; and

WHEREAS, *Dr. Duane Hyde*, later moved to King City after completing his schooling and became a doctor during the formative years of the hospital in King City, which would later come to be known as Mee Memorial Hospital, a hospital which provides many services for the members of its community; and

WHEREAS, *Dr. Duane Hyde*, was generous enough to give half of his annual salary as a donation to make the new hospital a reality as they were looking for matching funds to build a new facility, a donation which has made a lasting positive impact; and

WHEREAS, *Dr. Duane Hyde*, is one of the pioneers of medicine in King City and the only surviving member of the Southern Monterey County Medical Group; and

WHEREAS, *Dr. Duane Hyde*, personally approached his community and assisted in raising money for the construction of the new hospital; not only has he been a member of the King City Rotary since 1956, he has also served on the Elementary School Board, Monterey County Grand Jury, and Natividad Board of Trustees.

NOW, THEREFORE BE IT RESOLVED, that the Monterey County Board of Supervisors, on behalf of the County and all citizens thereof, honors *Dr. Duane Hyde* as a 2013 Monterey County Veterans Services Advisory Committee "Veteran of the Year" and wishes him continued success, peace and happiness in all of his future endeavors.
