

**AMENDMENT # 1  
TO AGREEMENT BETWEEN  
COUNTY OF MONTEREY & JIM GUY, D.B.A. INTROSPECT**

**THIS AMENDMENT** is made to the Professional Services Agreement by and between **INTROSPECT hereinafter** "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County" for the assessment, testing, substance abuse intervention and residential drug and alcohol treatment program for male and female inmates through funds provided by the Inmate Welfare Fund at the Monterey County Sheriff's Office, Custody Operations Bureau.

**WHEREAS**, the County and CONTRACTOR wish to amend the Agreement to include additional services resulting from newly granted AB 109 funding. And;

**WHEREAS**, the County and CONTRACTOR wish to amend the Agreement to increase the amount payable by \$58,551 for fiscal year 2012-2013 and \$19,517 for fiscal year 2013-2014 from the newly granted AB109 funds.

**NOW THEREFORE**, the County and CONTRACTOR hereby agree to amend the Agreement in the following manner:

1. **SERVICES TO BE PROVIDED** shall be amended to the following;  
"The County hereby engages CONTRACTOR to perform, and CONTRACTOR hereby agrees to perform, the services described in **both Exhibit A as attached to the Agreement and Exhibit A1 as attached hereto this AMENDMENT #1** in conformity with the terms of this Agreement. The services are generally described as follows: Provide assessment, testing, substance abuse intervention and residential drug and alcohol treatment program for male and female through funds provided by the Inmate Welfare Fund and the AB 109 Fund".
2. Section 2. "PAYMENTS BY THE COUNTY" shall be amended to the following;  
"County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A per this Agreement **and Exhibit A1 per Amendment #1**, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the following:  
**FISCAL YEAR 2012-2013 - \$225,555.00**  
**FISCAL YEAR 2013-2014 - \$186,521.00**  
**FISCAL YEAR 2014-2015 - \$167,004.00"**
3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the Agreement.
4. A copy of this AMENDMENT shall be attached to the original Agreement approved by the County's Board of Supervisors on September 11, 2012 and executed by the County on September 20, 2012.
