Issue Report Pursuant to Government Code 65858(d) Regarding
Measures Taken To Alleviate the Condition that led to the
Enactment of Interim Urgency Ordinance No. 5302......

WHEREAS, on May 22, 2018, the Monterey County Board of Supervisors adopted Interim Urgency Ordinance No. 5302 prohibiting, on a temporary basis and pending development of new regulations, new wells in a defined "Area of Impact" where seawater intrusion is evident and in the Deep Aquifers in the Salinas Valley Groundwater Basin, with specified exemptions; and

WHEREAS, Government Code Section 65858(d) requires that ten days prior to the expiration of an interim ordinance or any extension thereof, the Board of Supervisors shall issue a written report describing the measures taken to alleviate the conditions which led to the adoption of the interim urgency ordinance.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors issues this report describing the following measures that have been taken to alleviate the conditions which led to the adoption of Interim Urgency Ordinance No. 5302:

In order to avoid the approval of new well applications in a defined "Area of Impact" where seawater intrusion is evident and in the Deep Aquifers in the Salinas Valley Groundwater Basin, and to provide certainty and uniformity in the processing of well permit applications that are subject to the Ordinance, the County through its Environmental Health Bureau has taken the following measures in accordance with the Ordinance:

- a. Has not accepted nor processed applications for new wells in a defined "Area of Impact" and Deep Aquifers in the Salinas Valley Groundwater as identified in the Ordinance, except as allowed under the Ordinance;
- b. Continues to process those applications for such exceptions allowed under the Ordinance in accordance with Section 5, Exemptions, of the Ordinance;
- c. Notified the public of the Ordinance and its Exhibits A and B by posting the Ordinance on the Monterey County Health Department website; and
- d. Sent written notification of the Ordinance to all known well-drilling associates.
