Loss of nine (9) vacant Deputy District Attorney (DDA) positions—21% of our general fund attorney staff

We reluctantly accept not funding two (2) victim advocates (20%) and two (2) legal secretary positions (10%) and 4 DDA positions in FY 2025-

Asking for additional funding for five (5) DDA positions which will result in a 10% cut in general fund attorney staff

Attorney Staffing Challenges



Monterey County General Fund Contribution

Only 53% of budget is county-funded (Net County Cost)

Contiguous counties:

San Benito 87%, Santa Cruz 66%, San Luis Obispo 62%

Grants and other external sources (47%) are not directed towards core functions

(e.g. welfare, healthcare, insurance and workers comp fraud; consumer and environmental crime, and prison prosecutions)

General fund cuts impact core prosecutions (e.g., murder, sexual assault, domestic violence, robbery, gang, etc.)

County' General Fund Investm ent in DA Highly Leverag

- If we can't file or prosecute cases, the tax dollars invested in police departments and their investigatory time are wasted
- Weakened public safety
- Unable to provide justice to victims of crime

Service Cut: Filing DDA



15,000+ cases reviewed each year



Unfiled misdemeanors may be dismissed due to statute of limitations



Delays in filing cases are unfair to defendants and victims alike

Untenable Over Time: Early Resolution Court

Staffing requires 2 experienced DDAs; 1 currently unfilled


Inexperienced DDAs rotate in, causing impacts elsewhere

Untenable over Time: Collaborative Court

Court is dedicated to treatment, compliance and mentoring rather than litigation and provides support to veterans, the mentally ill, and those struggling with substance abuse

Due to staff shortages, position is currently staffed by an attorney manager, while inexperienced misdemeanor deputies go unsupervised until court is not in session

Untenable Over Time: Cold Case Unit

\$1,715,735 (\$343,147 each)



5 DDA I Positions at Step 2:

\$666,190

Conclusion

We can't fully cover our court and other responsibilities now—No surplusage

Eliminating 5 positions means no path forward

Request funding for these 5 DDA positions

Request freezing-not elimination-of all open positions you determine not to fund
