Honoring Congresswoman Zoe Lofgren for Her Trailblazing Leadership and Dedication to Women, Democracy, and Justice

WHEREAS, Congresswoman Zoe Lofgren has served with distinction in the United States House of Representatives for thirty years, currently representing the 18th District of California, which encompasses the diverse and vibrant communities of Monterey, San Benito, Santa Clara, and Santa Cruz counties; and

WHEREAS, Congresswoman Lofgren is a lifelong public servant whose deep roots in the Bay Area and working-class upbringing shaped her commitment to justice, opportunity, and public service; and

WHEREAS, Congresswoman Lofgren has been a champion for women and families, advocating for gender equity, fair access to education, reproductive rights, and policies that support working mothers and caregivers; and

WHEREAS, Congresswoman Lofgren was among the first women elected to the Santa Clara County Board of Supervisors, helping to usher in a historic female majority and proving to be a role model for women in both local and national government; and

WHEREAS, Congresswoman Lofgren served as a House Manager during the first impeachment trial of President Donald J. Trump in 2020, demonstrating her commitment to accountability and justice; and

WHEREAS, Congresswoman Lofgren, during the 117th Congress, showed unwavering commitment to upholding democracy and the rule of law, notably as a key member of the Select Committee to Investigate the January 6th attack on the United States Capitol, and as an author and advocate of comprehensive election reform through the For the People Act and the Presidential Election Reform Act; and

WHEREAS, her leadership in immigration policy has centered around the needs of women and families, ensuring humane treatment, due process, and opportunity for those seeking a better life in the United States—efforts that have earned the trust of farmworkers, immigrant communities, and civil rights organizations across the country; and

WHEREAS, Congresswoman Lofgren has long been a pioneer in science, technology, and digital rights policy, advocating for inclusion in STEM, safeguarding internet freedoms, and ensuring the responsible use of emerging technologies; and

WHEREAS, throughout her tenure, Congresswoman Lofgren has mentored, empowered, and inspired generations of women in public service, law, and advocacy—demonstrating through action what it means to lead with compassion, courage, and conviction.

NOW, THEREFORE, BE IT RESOLVED, that we honor and commend Congresswoman Zoe Lofgren for her extraordinary contributions benefitting women—an advocate for justice, a defender of democracy, and a trailblazer for equality whose legacy will continue to uplift the voices of women and girls across the nation.
