Adopted Ordinance 5229:

- a. Amending Section 12.24.010 of the Monterey County Code to designate the following roads as through highways: Barloy Canyon Road from Watkins Gate Road generally southeast to its terminus; Inter-Garrison Road from Reservation Road to Sherman Boulevard, from Sherman Boulevard to Schoonover Road, and from Schoonover Road to its terminus 500 feet east of the centerline of Abrams Drive; Sherman Boulevard from Inter-Garrison Road to West Camp Street; Watkins Gate Road from West Camp Street generally northeast to its terminus; and West Camp Street from Sherman Boulevard generally southeast to its terminus in the East Garrison area, in the unincorporated area of the County of Monterey; and
- b. Amending Section 12.24.020 of the Monterey County Code to establish a three-way stop intersection at Inter-Garrison Road and Sherman Boulevard and a three-way stop intersection at Sherman Boulevard and West Camp Street in the East Garrison area, in the unincorporated area of the County of Monterey.

#### ORDINANCE NO. 5229

#### AN ORDINANCE OF THE COUNTY OF MONTEREY, STATE OF CALIFORNIA, AMENDING SECTIONS 12.24.010 AND 12.24.020 OF THE MONTEREY COUNTY CODE RELATING TO THROUGH HIGHWAYS AND STOP INTERSECTIONS ON COUNTY HIGHWAYS

#### **County Counsel Summary**

This ordinance amends section 12.24.010 of the Monterey County Code to designate the following roads as through highways: Barloy Canyon Road from Watkins Gate Road generally southeast to its terminus; Inter-Garrison Road from Reservation Road to Sherman Boulevard, from Sherman Boulevard to Schoonover Road, and from Schoonover Road to its terminus 500 feet east of the centerline of Abrams Drive; Sherman Boulevard from Inter-Garrison Road to West Camp Street; Watkins Gate Road from West Camp Street generally northeast to its terminus; and West Camp Street from Sherman Boulevard generally southeast to its terminus. The ordinance also amends section 12.24.020 of the Monterey County Code to establish a three-way stop intersection at Inter-Garrison Road and Sherman Boulevard and a three-way stop intersection at Sherman Boulevard and West Camp Street. These through highways and stop intersections are in the East Garrison area of the unincorporated area of the County of Monterey.

The Board of Supervisors of the County of Monterey ordains as follows:

SECTION 1. PURPOSE AND FINDINGS.

Pursuant to Article XI, section 7 of the California Constitution, the County of Monterey may adopt and enforce ordinances and regulations not in conflict with general laws to protect and promote the public health, safety, and welfare of its citizens. California Vehicle Code Section 21354 authorizes the County of Monterey to designate any highway under its jurisdiction as a through highway and to erect stop signs at entrances thereto or to designate any intersection under its exclusive jurisdiction as a stop intersection and erect stop signs at one or more entrances thereto.

The County has determined that traffic in the area would be best served by designating the following roads as through highways: Barloy Canyon Road from Watkins Gate Road generally southeast to its terminus; Inter-Garrison Road from Reservation Road to Sherman Boulevard, from Sherman Boulevard to Schoonover Road, and from Schoonover Road to its terminus 500 feet east of the centerline of Abrams Drive; Sherman Boulevard from Inter-Garrison Road to West Camp Street; Watkins Gate Road from West Camp Street generally northeast to its terminus; and West Camp Street from Sherman Boulevard generally southeast to its terminus. The County has also determined that traffic in the area would be best served by establishing a three-way stop intersection at Inter-Garrison Road and Sherman Boulevard, and a three-way stop intersection at Sherman Boulevard and West Camp Street. These through

highways and stop intersections are in the East Garrison area of the unincorporated area of the County of Monterey.

SECTION 2. Section 12.24.010 of the Monterey County Code is amended by adding to that section the following paragraphs:

Barloy Canyon Road, from Watkins Gate Road generally southeast to its terminus;

Inter-Garrison Road, from Reservation Road to Sherman Boulevard, from Sherman Boulevard to Schoonover Road, and from Schoonover Road generally southeast to its terminus 500 feet east of the centerline of Abrams Drive;

Sherman Boulevard, from Inter-Garrison Road to the intersection of West Camp Street;

Watkins Gate Road, from West Camp Street generally northeast to its terminus;

West Camp Street, from Sherman Boulevard generally southeast to its terminus;

SECTION 3. Section 12.24.020 of the Monterey County Code is amended by adding to that section the following paragraphs:

Intersection of Inter-Garrison Road and Sherman Boulevard. Stops required at all three entrances to the intersection.

Intersection of Sherman Boulevard and West Camp Street. Stops required at all three entrances to the intersection.

SECTION 4. This ordinance shall become effective on the thirty-first day following its adoption.




