AMENDMENT NO. 3 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY AND UNITED WAY OF MONTEREY COUNTY

THIS AMENDMENT NO. 2 to Agreement, No. A-15050 ("AGREEMENT") for the provision of serving as the administrator of the COVID-19 Stipend Pilot program, is made by and between the County of Monterey, a political subdivision of the State of California (hereinafter referred to as "County"), on behalf of Monterey County Health Department, and United Way of Monterey County (hereinafter referred to as "CONTRACTOR") with respect to the following.

WHEREAS, on December 3, 2020, County and CONTRACTOR entered into AGREEMENT No. A-15050 in the amount of \$621,668 with a term of December 1, 2020 through December 31, 2020; and

WHEREAS, County and CONTRACTOR entered into AMENDMENT NO. 1 to said AGREEMENT to increase the total amount of the AGREEMENT to \$644,129 and extend the term of the AGREEMENT to June 30, 2021; and

WHEREAS, County and CONTRACTOR entered into AMENDMENT NO. 2 to said AGREEMENT to extend the term of the AGREEMENT through December 31, 2021; and

WHEREAS, County and CONTRACTOR wish to amend the AGREEMENT to extend the term through April 30, 2022.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend AGREEMENT in the following manner:

- 1. Paragraph 3.0 "TERM OF AGREEMENT" shall be amended by removing "The term of this AGREEMENT is from December 01, 2020 to December 31, 2021, unless sooner terminated pursuant to the terms of the AGREEMENT" and replacing it with "The term of this AGREEMENT is from December 01, 2020 to April 30, 2022, unless sooner terminated pursuant to the terms of this AGREEMENT."
- 2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT that are unchanged and unaffected by this AMENDMENT NO. 3 shall continue in full force and effect as set forth in the AGREEMENT.
- 3. This AMENDMENT NO. 3 shall be effective January 1, 2022.
- 4. A copy of this AMENDMENT NO. 3 shall be attached to the original AGREEMENT executed by the County on December 3, 2020.
