AMENDMENT NO. 5 TO THE SERVICES AGREEMENT BETWEEN NATIVIDAD MEDICAL CENTER (COUNTY OF MONTEREY) AND NANCY LOMELI dba SAL'S TAXI FOR LAB SPECIMEN AND PATIENT TRANSPORTATION

This Amendment No. 5 to the County of Monterey, Natividad Medical Center (NMC) Agreement for Services is made and entered into, by and between the County of Monterey (hereinafter "County"), a political subdivision of the State of California, on behalf of Natividad Medical Center, an acute care hospital (hereinafter, "NMC"), and Nancy Lomeli dba Sal's Taxi (hereinafter "CONTRACTOR"); From this point forward, the party referenced previously as "NMC" shall be referenced as "COUNTY" and collectively, COUNTY and CONTRACTOR are referred to as the "Parties" to this Agreement, with respect to the following:

RECITALS

WHEREAS, the County of Monterey on behalf of Natividad Medical Center and Sal's Taxi had previously entered into an Agreement for Services (hereinafter "Agreement") on February 1, 2017 to provide lab specimen and patient transportation services to NMC with a three year and four month term and a total Agreement amount not to exceed \$100,000; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on July 28, 2020 via Renewal and Amendment No. 1 to extend the term for an additional one year period through May 30, 2021 and to add an additional \$25,000 thereby increasing the total Agreement amount to \$125,000; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on May 14, 2021 to extend it for an additional one (1) year period through May 30, 2022 to allow for services to continue with additions to the original scope of work attached hereto as "Exhibit A-2 per Amendment No. 2" and to increase the amount payable by \$25,000 for a total Agreement amount of \$150,000; and

WHEREAS, the Agreement expired on May 30, 2022; and

WHEREAS, the Parties renewed and amended the Agreement on the same or similar terms, beginning May 31, 2022 and extended the term for an additional one (1) year period (May 31, 2022 through May 30, 2023) for a revised full Agreement term of February 1, 2017 through May 30, 2023, and increased the amount payable by \$50,000 for a total Agreement amount of \$200,000; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on May 31, 2023 via Amendment No. 4 to extend the term for an additional one (1) year period for a revised full Agreement term of February 1, 2017 through May 30, 2024, with an increase of \$10,000 to the total aggregate amount not to exceed \$210,000; and

WHEREAS, NMC and CONTRACTOR wish to amend the Agreement to increase the payable amount by \$40,000 for a total Agreement amount not-to-exceed \$250,000, with no changes to the Agreement term or scope of work.

AGREEMENT

NOW THEREFORE, the Parties agree as follows:

The Agreement is hereby amended on the terms and conditions as set forth in the original Agreement, Renewal and Amendment No. 1, Amendment No. 2, Renewal and Amendment No. 3, Amendment No. 4, and in this Amendment No. 5 incorporated herein by this reference, except as specifically set forth below.

- 1. "PAYMENTS BY NMC" Section second sentence shall be amended to the following: "The total amount payable by COUNTY to CONTRACTOR under this Agreement shall not exceed the sum of \$250,000."
- 2. If there is any conflict or inconsistency between the provisions of Agreement, or Amendment No. 5, the provisions of this Amendment No. 5 shall govern.
- 3. This Amendment No. 5 is effective when signed by the Parties.
