

RENEWAL & AMENDMENT NO. 3
To the AGREEMENT BETWEEN THE
COUNTY OF MONTEREY
and
STAR SANITATION LLC

STAR SANITATION, LLC., hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “COUNTY” entered into a standard agreement dated April 20, 2020, for the provision Rental of Generators, Fencing, Portable Handwashing and Sanitation Units and Pumping and Disposal Services (“AGREEMENT”).

WHEREAS, COUNTY and CONTRACTOR amended the AGREEMENT on April 29, 2020 via AMENDMENT NO. 1 to add additional services; and

WHEREAS, COUNTY and CONTRACTOR amended the AGREEMENT on June 8, 2020 via AMENDMENT NO. 2 to extend the term of the AGREEMENT through and including August 31, 2020; and

WHEREAS, COUNTY and CONTRACTOR wish to renew and extend the term of the AGREEMENT through and including June 30, 2023, to add additional services, and to add all COVID-19 County Alternative Housing Sites; and

NOW THEREFORE,

For valuable consideration, the sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows:

1. Section 1, “GENERAL DESCRIPTION”, paragraph 1.0 shall be amended by removing “Pumping & Disposal Services for Septic Tanks, for COVID19 at Monterey County Fairgrounds. Rental of Generators, and Fencing,” and replacing it with: “Rental of Generators, Fencing, Portable Handwashing and Sanitation Units and Pumping and Disposal Services for any County COVID-19 Alternative Housing Site.”
2. Section 2, “TERM OF AGREEMENT”, paragraph 2.01 shall be amended by removing “The term of this Agreement will be from April 20, 2020 to August 31, 2020, unless sooner terminated pursuant to the terms of this Agreement.” and replacing it with: “The term of this Agreement will be from April 20, 2020 to June 30, 2023, unless sooner terminated pursuant to the terms of this Agreement.”
3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this RENEWAL AND AMENDMENT NO. 3 to the AGREEMENT and shall continue in full force and effect as set forth in the AGREEMENT.
4. A copy of this RENEWAL AND AMENDMENT NO. 3 shall be attached to the original AGREEMENT dated April 20, 2020.
