

**AMENDMENT NO. 4
TO PROFESSIONAL SERVICES AGREEMENT
BETWEEN COUNTY OF MONTEREY AND
HARRIS & ASSOCIATES, INC.**

THIS AMENDMENT NO. 4 to Professional Services Agreement No. A-12869 between the County of Monterey, a political subdivision of the State of California (hereinafter, “County”) and Harris & Associates, Inc. (hereinafter, “CONTRACTOR”) is hereby entered into between the County and the CONTRACTOR (collectively, the “Parties”) and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into Professional Services Agreement No. A-12869 with County on August 18, 2015 (hereinafter, “Agreement”) to provide on-call construction management services for various general projects located in Monterey County, California (hereinafter, “services”) through July 21, 2018 for an amount not to exceed \$5,000,000; and

WHEREAS, Agreement was amended by the Parties on July 23, 2018 (hereinafter, “Amendment No. 1”) to update the Indemnification for Construction Management Professional Services Claims provision and to extend the term for one (1) additional year through July 21, 2019 with no increase in the not to exceed amount; and

WHEREAS, Agreement was amended by the Parties on July 18, 2019 (hereinafter, “Amendment No. 2”) to extend the term for one (1) additional year through July 21, 2020 with no increase in the not to exceed amount; and

WHEREAS, Agreement was amended by the Parties on July 10, 2020 (hereinafter, “Amendment No. 3”) to extend the term for one (1) additional year through July 21, 2021 with no increase in the not to exceed amount; and

WHEREAS, County has a continued need for services beyond the anticipated five (5) year Agreement term allowed per Request for Qualifications (RFQ) #10476; and

WHEREAS, additional time is necessary to allow CONTRACTOR to continue to provide the services required by the County and to allow County staff to prepare and process a new RFQ; and

WHEREAS, the Parties agree that the Fee Schedule in Exhibit B – Payment Provisions of the Agreement remains valid through July 21, 2022; and

WHEREAS, the CONTRACTOR’s Fee Schedule requires an update effective July 22, 2022; and

WHEREAS, the Parties wish to further amend the Agreement to extend the term for approximately thirty (30) additional months to December 31, 2023 and to update the Fee Schedule effective July 22, 2022 as indicated in “Exhibit B-1 Revised Fee Schedule” and incorporated by this reference with no associated dollar amount increase to allow CONTRACTOR to continue to provide services identified in the Agreement and as amended by this Amendment No. 4.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

1. Amend the first paragraph of Section 2, “Term of Agreement”, to read as follows:

The term of this Agreement is from July 21, 2015 to December 31, 2023, unless sooner terminated pursuant to the terms of this Agreement.

2. Amend Section 3, “Additional Provisions/Exhibits”, to add “Exhibit B-1, Revised Fee Schedule”, effective July 22, 2022.
3. In all places within the Agreement, any reference to the Fee Schedule in “Exhibit B, Payment Provisions” is hereby replaced with “Exhibit B-1, Revised Fee Schedule”, effective July 22, 2022.
4. In all places within the Agreement, any reference to Resource Management Agency is hereby replaced with Department of Public Works, Facilities, & Parks.
5. All other terms and conditions of the Agreement, including all Exhibits thereto, remain unchanged and in full force.
6. This Amendment No. 4 and all previous amendments shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
7. The recitals to this Amendment No. 4 are incorporated into the Agreement and this Amendment No. 4.

IN WITNESS WHEREOF, the Parties hereto have executed this Amendment No. 4 to the Agreement which shall be effective as of the last date opposite the respective signatures below.
