*The proposed project is the construction of a mini storage facility. The site is now being farmed in strawberries along with the surrounding property. The mini storage will be constructed in three phases and will contain 614 storage units and an office. The mini storage operation will have two employees. Construction will take place on 5 acres and contain a total of 73,169 square feet of building area at 33% lot coverage. A single family residence exists on the site and a 6' masonry wall encloses the back yard. The site is zoned Light Commercial. The property north and south and west of the site is zoned Light Commercial. The zoning across the street, easterly of Harrison Road is in an area of development concentration and no zoning is attached to this property at this time. The site is level and fronts on Harrison Road.*

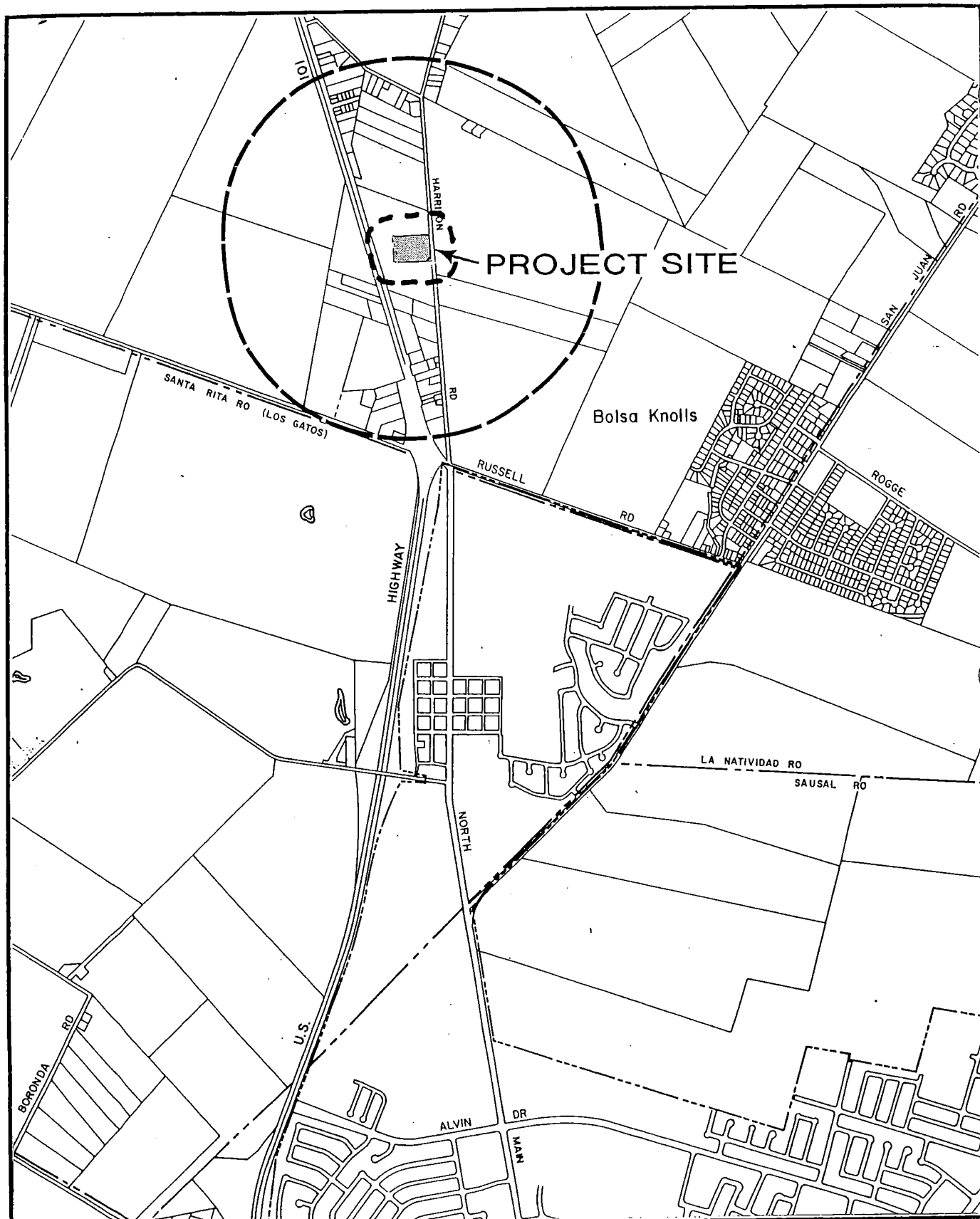

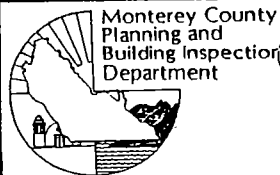

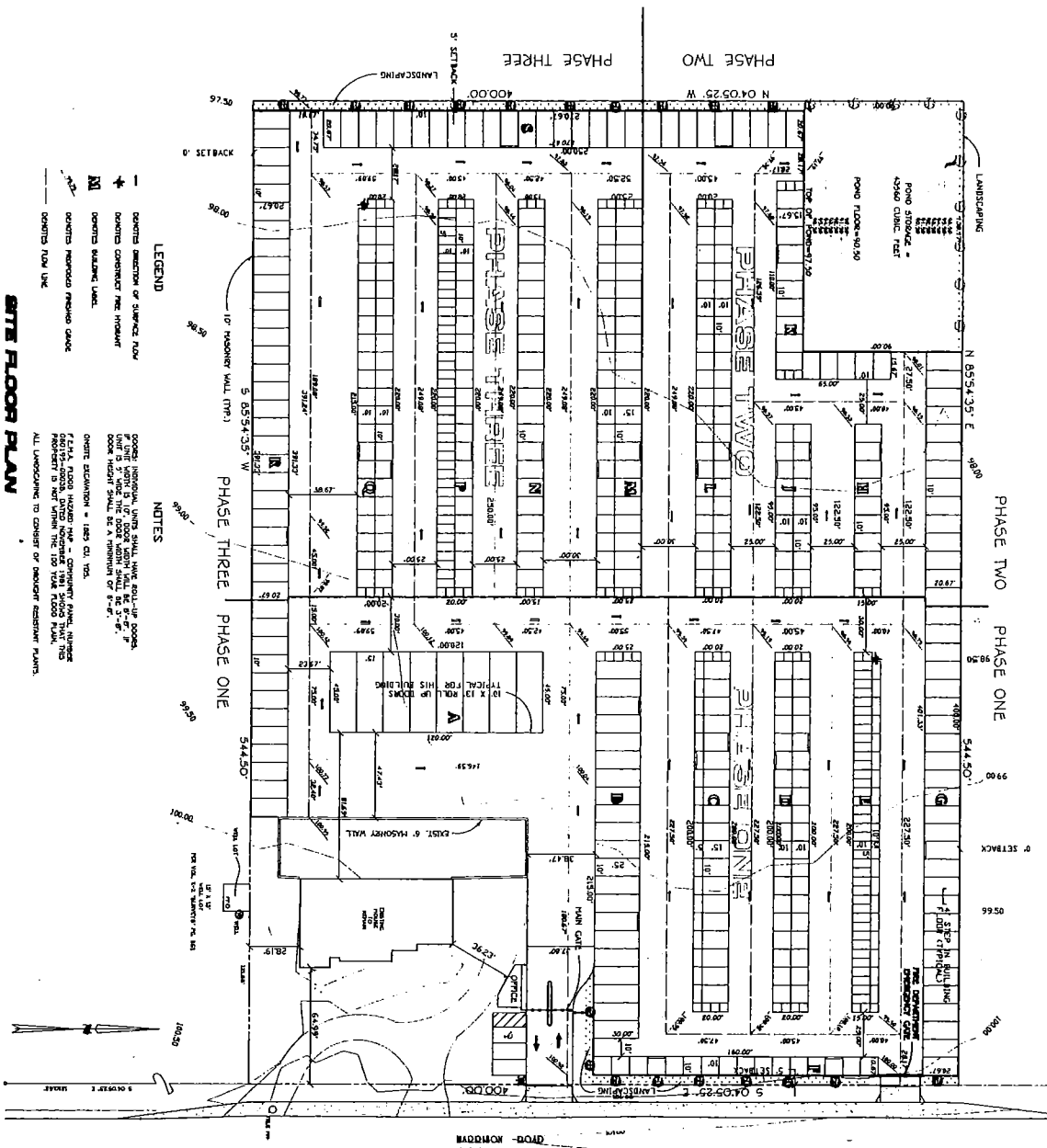
