Our evaluation of recent 9-1-1 emergency call volume qualifies the MONTEREY EMERGENCY COMMUNICATIONS for an annual accrual rate of \$121,000. Based on the June 30, 2004 acceptance date of your current E9-1-1 phone system, the amount of CPE Accrued Allotment funds accrued as of January 1, 2014 is \$1,210,000. Effective February 19, 2014, the accrual process has been sunset. There will no longer be additional years of accrual. Extended maintenance of existing CPE (beyond the original five year contract term) will be deducted from CPE Accrued Allotment until CPE replacement.

All accrued CPE Accrued Allotment funds must be spent by June 30, 2016.
