

AMENDMENT No. 1 TO
340B CONTRACT PHARMACY SERVICES AGREEMENT


This Amendment ("Amendment"), made and entered into by and between the below named 340B covered entity ("340B Entity") and Walgreen Co. ("Walgreens"), is effective June 15, 2015 ("Amendment Effective Date") and amends that certain agreement between the parties for 340B contract pharmacy services provided by Walgreens ("340B Agreement").

AMENDED TERMS

1. The parties are no longer utilizing Central Inventory Replenishment Sites; therefore, all references to "Central Inventory Replenishment Sites" or "CIRS" in the 340B Agreement are hereby deleted. Accordingly, the defined term "Central Inventory Replenishment Site" is deleted from the Definitions article of the 340B Agreement and replaced with "Intentionally Reserved" so that the numbering in the Definitions article remains unchanged. For avoidance of doubt, any locations identified as Central Inventory Replenishment Sites in an exhibit or attachment to the 340B Agreement are hereby deleted.
2. All references to "Distribution Center Locations" in the 340B Agreement, if any, are hereby deleted. In the event that the Definitions article of the 340B Agreement includes the term "Distribution Center Location," such term is deleted and replaced with "Intentionally Reserved" so that the numbering in the Definitions article remains unchanged. For avoidance of doubt, any locations identified as Distribution Center Locations in an exhibit or attachment to the 340B Agreement are hereby deleted.
3. The parties restate all other provisions of the 340B Agreement and agree that all such provisions remain in effect.

340B Entity may accept this Amendment by: (1) signing below where indicated and returning the signed Amendment to Walgreens prior to the Effective Date; (2) failing to provide Walgreens evidence of its written objection prior to the Amendment Effective Date; or (3) approving the removal of the Central Inventory Replenishment Sites and Distribution Center Locations (if any) from the list of contract pharmacies on the HRSA website.




