AMENDMENT NO. 3 TO STANDARD AGREEMENT BETWEEN COUNTY OF MONTEREY AND NETRONIX INTEGRATION, INC.

THIS AMENDMENT NO. 3 to Standard Agreement No. A-13727 between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and Netronix Integration, Inc. (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into Standard Agreement No. A-13727 with County on November 25, 2015 (hereinafter, "Agreement") to provide annual security maintenance and system software support for the access control systems and CCTV systems, including on-call service and repairs, for the systems at 168 West Alisal Street and 1488 Schilling Place in Salinas (hereinafter, "services") through September 30, 2016 for an amount not to exceed \$45,000.00; and

WHEREAS, Agreement was amended by the Parties on September 12, 2016 (hereinafter, "Amendment No. 1", including Exhibit A-1 – Scope of Services/Payment Provisions) to extend the term for one (1) additional year to September 30, 2017 and to increase the amount by \$52,730.00 which resulted in a total not to exceed amount of \$97,730.00; and

WHEREAS, Agreement was amended by the Parties on September 29, 2017 (hereinafter, "Amendment No. 2", including Exhibit A-2 – Scope of Services/Payment Provisions) to extend the term for three (3) additional years to September 30, 2020 and to increase the amount by \$122,235.00 which resulted in a total not to exceed amount of \$219,965.00; and

WHEREAS, due to unanticipated on call service and repairs needed for the aging systems, the County has experienced an increase in on call service and repairs; and

WHEREAS, additional funding is necessary to allow CONTRACTOR to continue to provide on call service and repairs as required by the County; and

WHEREAS, the Parties wish to further amend the Agreement to increase the amount by \$40,000 for a total not to exceed \$259,965 with no associated term extension to allow CONTRACTOR to continue to provide services identified in the Agreement and as amended by this Amendment No. 3.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

1. Amend the second sentence of Section 2.01 of Paragraph 2.0, "Payment Provisions", to read as follows:

The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$259,965.05.

2. Amend the total amount of "ITEM B: On Call Service & Repairs" in paragraph B.1, Compensation/Payment, of section B, Payment Provisions, of Exhibit A-2 – Scope of Services/Payment Provisions, to read as follows:

ITEM B: On Call Service & Repairs

\$55,000.00

- 3. All other terms and conditions of the Agreement, including all Exhibits thereto, remain unchanged and in full force.
- 4. This Amendment No. 3 and the previous amendment shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
- 5. The recitals to this Amendment No. 3 are incorporated into the Agreement and this Amendment No. 3.
