


CERTIFICATE OF COMPLETION

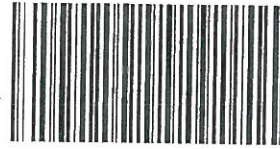




