

**AMENDMENT NO. 2 TO AGREEMENT  
BY AND BETWEEN  
COUNTY OF MONTEREY AND  
THE DATA CENTER, LLC.**

**THIS AMENDMENT NO. 2** to the County of Monterey Standard Agreement No. A-17066 (“Agreement”) is entered into by and between the County of Monterey, a political subdivision of the State of California, (“COUNTY”) and The Data Center, LLC. (“CONTRACTOR”).

**WHEREAS**, the COUNTY entered into a STANDARD AGREEMENT with CONTRACTOR in the amount of \$15,000 for the term of September 1, 2024, to June 30, 2027, to provide printing and mailing services; and

**WHEREAS**, the COUNTY and CONTRACTOR amended AGREEMENT No. A-17066 to revise EXHIBIT A: SCOPE OF SERVICES/PAYMENT PROVISIONS to reflect an increase in rates, and an increase of \$70,000 to the budget as agreed to by both parties for a revised total AGREEMENT in the amount of \$85,000 for the same term of September 1, 2024, to June 30, 2027; and

**WHEREAS**, the COUNTY and CONTRACTOR wish to amend AGREEMENT No. A-17066 to add \$20,000 to the budget as agreed to by both parties for a revised total AGREEMENT amount of \$105,000 with no change to the scope of work, and no change to the term of September 1, 2024, to June 30, 2027; and

**NOW THEREFORE**, the COUNTY and CONTRACTOR hereby agree to amend the AGREEMENT as follows:

1. **Section 2.0, “Payment Provisions”, shall be amended by removing**, “The total amount payable by County to CONTRACTOR under this agreement shall not exceed the sum of \$85,000”, **and replacing it with** “The total amount payable by County to CONTRACTOR under this agreement shall not exceed the sum of \$105,000”.
2. Except as provided herein, all remaining terms, conditions, and provision of the AGREEMENT are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the AGREEMENT.
2. A copy of this Amendment No. 2 shall be attached to the original AGREEMENT executed by the County on September 9, 2024.
3. This Amendment No. 2 is effective upon execution.
