AMENDMENT #1 TO RFP#10800 PROFESSIONAL SERVICES AGREEMENT A-15790 COUNTY OF MONTEREY & RAY VARGAS INC., DBA ADVANCED TOWING

THIS AMENDMENT is made to the AGREEMENT A-15790 RFP#10800 for rotational towing services for evidence, abatement, accident/crime scene towing by and between **Ray Vargas Inc., dba Advanced Towing**, hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “County”.

WHEREAS, the County and CONTRACTOR entered into an AGREEMENT on June 1, 2022 via a Request for Proposals #10800 – Rotational towing services for evidence, abatement, accident/crime scene towing for the Monterey County Sheriff’s Office; and

WHEREAS, the County and CONTRACTOR wish to amend the current AGREEMENT by removing Attachment B and replacing it with Attachment B-1.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Section 5.1., “COMPENSATION AND PAYMENTS” shall be amended by removing Attachment B and replacing it with Attachment B-1, attached herein (effective November 7, 2022).
2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
3. A copy of the AMENDMENT shall be attached to the original AGREEMENT executed by the County on June 1, 2022.
