AMENDMENT NO. 3 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY AND CEPHEID

THIS AMENDMENT NO. 3 to the Agreement is made by and between the County of Monterey, a political subdivision of the State of California (hereinafter referred to as "County"), and Cepheid (hereinafter referred to as "CONTRACTOR") with respect to the following.

WHEREAS, on March 3, 2022, County and CONTRACTOR entered into Agreement in the amount of \$12,801.93 for the term March 3, 2022, through December 31, 2024, for the provision of providing three years of annual preventative maintenance services; and

WHEREAS, on March 23, 2023, County and CONTRACTOR entered into Amendment No. 1 to Agreement, for the purchase of new equipment and increasing the maximum contract liability to \$37,522; and

WHEREAS, on April 24, 2024, County and CONTRACTOR entered into Amendment No. 2 to Agreement, extending the term of Agreement to June 30, 2029, and to increase the maximum contract liability to \$197,333; and

WHEREAS, County and CONTRACTOR wish to increase the maximum contract liability to \$225,409, for the purchase of a four-year service agreement extension for the existing GeneXpert 4x4 Public Health Laboratory equipment.

NOW THEREFORE, County and CONTRACTOR hereby agree as follows:

- 1. Paragraph 2, "Payment Provisions", shall be amended by removing "The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$197,333." and replacing it with "The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$225,409.".
- 2. EXHIBIT A-2 is deleted and replaced in its entirety and attached hereto as EXHIBIT A-3. All references in the Agreement to EXHIBIT A-2 shall be construed to refer to EXHIBIT A-3.
- 3. Except as provided herein, all remaining terms, conditions, and provisions of the Agreement are unchanged and unaffected by this Amendment No. 3 and shall continue in full force and effect as set forth in the Agreement.
- 4. A copy of this Amendment No. 3 shall be attached to the original Agreement executed by County on March 3, 2022.
