WHEREAS, CASP advances its mission through the For Our Future / Para Nuestro Futuro campaign, a community-driven strategy grounded in data, centered on youth, and strengthened through deep and meaningful community engagement; and

WHEREAS, **Alexa Naranjo** has educated fellow youth on the dangers of substance use and its impact on teen health through radio interviews, community initiatives, and peer outreach efforts; and

WHEREAS, **Alexa Naranjo**'s ability to connect with others, mentor new volunteers, and inspire youth engagement highlights the critical role young people play in driving meaningful and lasting change in their communities; and

WHEREAS, **Alexa Naranjo**'s dedication exemplifies the core values of CASP by placing youth at the center of solutions and fostering a safer, healthier future for all.
