FIRST AMENDMENT TO PROFESSIONAL AND CALL COVERAGE SERVICES AGREEMENT

THIS FIRST AMENDMENT TO PROFESSIONAL AND CALL COVERAGE SERVICES AGREEMENT (the "Amendment") is made and entered into as of March 1, 2019, by and between COUNTY OF MONTEREY ("County") on behalf of NATIVIDAD MEDICAL CENTER ("Hospital"), and MONTEREY ANESTHESIA PROFESSIONALS, a California general partnership ("Contractor") with respect to the following:

RECITALS

- A. County owns and operates Hospital, a general acute care teaching hospital facility and Level II Trauma Center located in Salinas, California and operates an anesthesia department (the "**Department**") under its acute care license.
- B. Contractor and Hospital have entered into that certain Professional and Call Coverage Services Agreement dated January 1, 2017 (the "Agreement") pursuant to which Contractor provides Anesthesia Services.
- C. Hospital and Contractor desire to amend the Agreement to modify the staffing model due to increased hours in the Hospital's operating room, to add compensation for such additional staffing and to extend the term of the Agreement as set forth herein.

AGREEMENT

IN CONSIDERATION of the foregoing recitals and the mutual promises and covenants contained herein, Hospital and Contractor agree as follows:

- 1. <u>Defined Terms</u>. Capitalized terms not otherwise defined herein shall have the meaning ascribed to them in the Agreement.
- 2. <u>Section 5.1</u>. Section 5.1 to the Agreement is hereby amended and restated to read in its entirety as follows:
 - "5.1 <u>Term.</u> This Agreement shall become effective on January 1, 2017 (the "Effective Date"), and shall continue until the earlier of: (a) the effective date of any new agreement entered into by and between the Parties for the same or similar services as this Agreement, or (b) February 29, 2020 (the "Expiration Date"), subject to the termination provisions of this Agreement."
- 3. <u>Exhibit 1.2</u>. Exhibit 1.2 to the Agreement is hereby deleted and replaced in its entirety and attached hereto as <u>Exhibit 1.2</u>.
- 4. <u>Exhibit 2.1</u>. Exhibit 2.1 to the Agreement is hereby deleted and replaced in its entirety and attached hereto as <u>Exhibit 2.1</u>

- 5. <u>Counterparts</u>. This Amendment may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.
- 6. <u>Continuing Effect of Agreement</u>. Except as herein provided, all of the terms and conditions of the Agreement remain in full force and effect from the Effective Date of the Agreement.
- 7. Reference. After the date of this Amendment, any reference to the Agreement shall mean the Agreement as amended by this Amendment.

The Anesthesia Services shall be initially staffed as follows and may be modified by mutual agreement of the Parties from time to time as surgical volumes fluctuate and services are modified. Contractor shall adjust coverage as required to ensure patient safety, quality care, high efficiencies and patient satisfaction.

Exhibit 2.1

COMPENSATION

1. Annual Compensation.

- (a) Hospital shall pay to Contractor an amount equal to Three Million Five Hundred Sixty-One Thousand Five Hundred Thirty-Five Dollars (\$3,561,535) per Contract Year for Coverage Services provided pursuant to this Agreement (the "Annual Compensation"). Such compensation shall be paid monthly in the amount of Two Hundred Ninety-Six Thousand Seven Hundred Ninety-Five Dollars (\$296,795) per month.
- (b) Hospital shall pay to Contractor an amount equal to Twenty-Eight Thousand Nine Hundred Forty-Seven Dollars (\$28,947) per month for Operating Room Extended Hours provided under this Agreement according to the staffing levels in **Exhibit 1.2**, fewer services than as stated will result in a proportionate pro-rata reduction in this fee at the rate of One Hundred Sixty-Seven Dollars (\$167) per hour.
- 2. <u>Medical Director Services</u>. Hospital shall pay to Contractor an amount equal to Twenty-Eight Thousand Eight Hundred Dollars (\$28,800) per Contract Year for Director Services provided pursuant to this Agreement ("Director Services Compensation"). Such compensation shall be paid monthly in the amount of Two Thousand Four Hundred Dollars (\$2,400) per month.
- 3. <u>Timing.</u> Hospital shall pay the Annual Compensation and Director Services Compensation in equal monthly installments, with each payment due for Services performed by Contractor in the immediately preceding month within thirty (30) days of the end of the month. The County of Monterey Standard Payment Terms for contracts/PSAs and paying invoices is "30 days after receipt of the certified invoice in the Auditor-Controller's Office".
- 4. <u>Incentive Compensation</u>. In addition to the Annual Compensation, Contractor shall be eligible for an incentive bonus of up to One Hundred Fifty Thousand Dollars (\$150,000) per Contract Year (the "Incentive Compensation"). Such Incentive Compensation shall be based on the patient satisfaction data collected by Professional Research and core measure performance using Hospital's Core Measure data. Hospital shall pay Contractor the Incentive Compensation on an annual basis, commencing twelve (12 months from the Effective Date (each such payment occurring on the "Payment Date"), and shall be calculated quarterly as follows for the twelve (12) months preceding each Payment Date.
